INTEREST SHALL ACCRUE ON ANY OVERDUE ACCOUNT BALANCE AT A RATE OF 1½ % PER MONTH UNTIL PAID IN FULL. THERE WILL BE NO REFUND OR CREDIT GIVEN FOR CLASSES NOT ATTENDED, OFFICE STAFF WILL SCHEDULE MAKE-UP CLASSES, FOR ABSENCES DUE TO ILLNESS. A \$30.00 FEE WILL BE CHARGED FOR ALL RETURNED CHECKS. NO REFUNDS OR COSTUMES WILL BE GIVEN TO STUDENTS WHO HAVE DISCONTINUED THEIR CLASSES PRIOR TO THE RECITAL, ONCE COSTUMES ARE ORDERED. COSTUMES AND RECITAL TICKETS WILL NOT BE RELEASED IF STUDENT'S TUITION BALANCE IS NOT PAID IN FULL.
